**STANDING RULES
OF THE
ANNUAL MEMBERSHIP MEETING**

June 6, 2019, Traverse City, Michigan

1. Members, guests, and delegates shall register at the Registration table before entering the business meeting room. Delegates shall check in at the Credentials desk and sit in the designated seating area.
2. The Annual Membership Meeting shall be called promptly and delegates are required to be in their seats promptly for voting.
3. Name badges are required for admission to the Annual Membership Meeting.
4. A person wishing to address the Presiding Chair shall rise, give his/her name, club and city.
5. Each motion offered during the Annual Membership Meeting shall be written, signed by the motion maker and by the person seconding the motion, and handed to the MGC Recording Secretary. Both the motion maker and the person seconding the motion must be voting delegates to the Annual Membership Meeting.
6. No Delegate shall speak in debate more than twice on the same question or longer than two minutes unless a motion is made to suspend the rules to allow him/her to speak two more minutes, seconded and passed by a majority of the voting delegates.
7. Notices for announcements at the Annual Membership Meeting shall be in writing and signed. Assigned Pages will pass notes and messages to the Presiding Chair.
8. All cellular phones/electronic devices must remain turned OFF during ALL Conference functions.
